Safe Systems of Work

Line of Fire

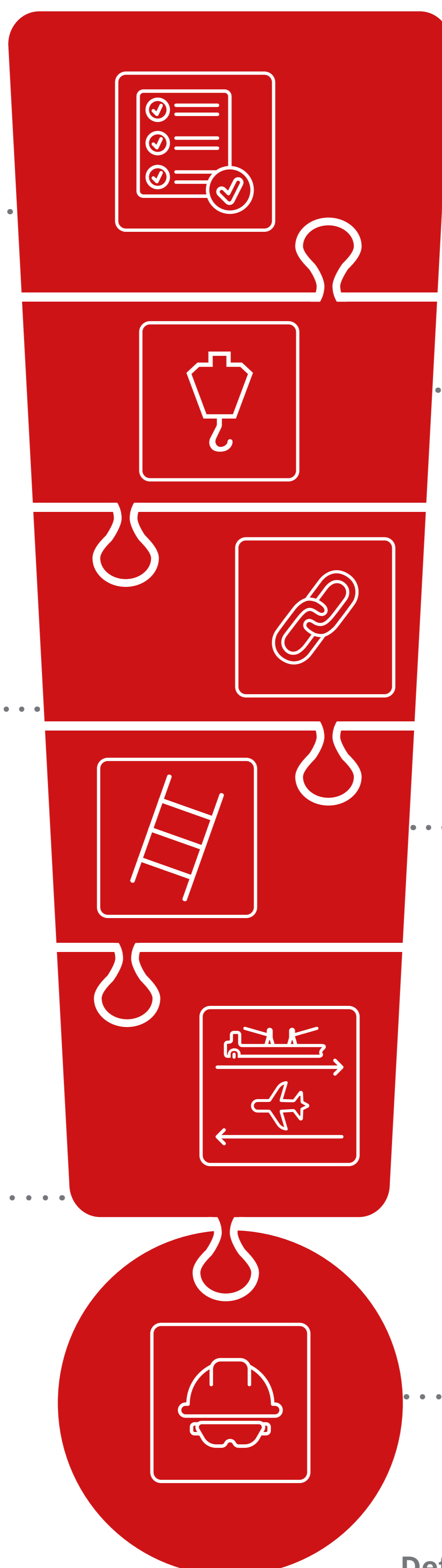

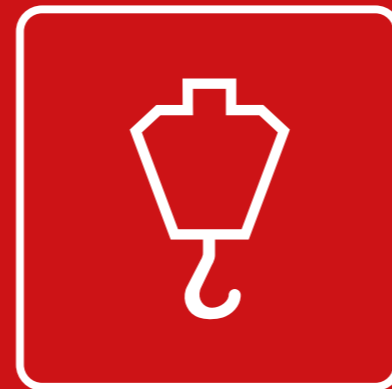

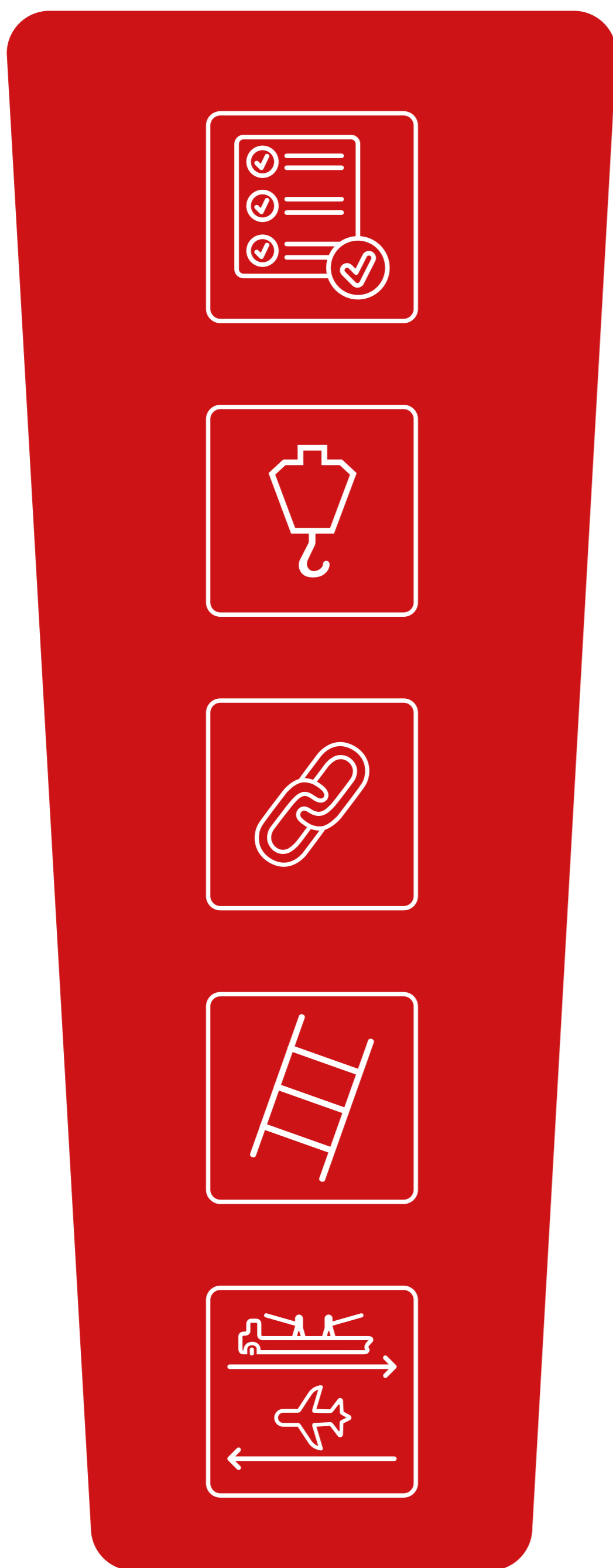
